01. Why am I using Cultiva Frosted Oranges AIO Live Resin Vaporiser?

Cultiva Frosted Oranges AIO Live Resin Vaporiser contains the active ingredient delta-9-tetrahydrocannabinol (THC) and other minor phytocannabinoids. Cultiva Frosted Oranges AIO Live Resin Vaporiser should only be used to treat specific conditions and symptoms authorised by your healthcare practitioner. This medication is only available with a doctor's prescription and approval via the TGA Special access scheme or authorised prescriber scheme. Ask your doctor if you have any questions about why Cultiva Frosted Oranges AIO Live Resin Vaporiser has been prescribed for you.

Therapeutic Class

Cannabis is a controlled drug. Possession without authority is illegal. Poison Schedule: Schedule 8.

Conditions/Symptoms

The Therapeutic Goods Administration (TGA) has approved Special Access Scheme (SAS) applications for medicinal cannabis including, but not limited to, the following:

- Chemotherapy-induced nausea and vomiting (CINV)
- Refractory paediatric epilepsy
- Neuropathic and chronic pain
- Palliative care
- Cancer pain
- Spasticity from neurological conditions (e.g., multiple sclerosis)
- Anorexia and wasting associated with chronic illness (e.g., cancer)
- Insomnia and sleep disorders
- Post-Traumatic Stress Disorder (PTSD)
- Anxiety
- Attention-Deficit/Hyperactivity Disorder (ADHD)
- Symptom relief from autoimmune conditions

02. What should I know before using Cultiva Frosted Oranges AIO Live Resin Vaporiser?

Warnings

- Do not use Cultiva Frosted Oranges AIO Live Resin Vaporiser if:
- You are allergic to THC (delta-9-tetrahydrocannabinol), CBD (cannabidiol), or cannabis extracts.
 - You are less than 18 years old
 - The use-by date printed on the packaging has expired or the package looks like it has been tampered with.
 - You have a history of drug dependence, including alcohol dependence.

Always check the ingredients to make sure you can use this medicine.

Check with your doctor if you have any other medical conditions such as:

- Heart problems
- Lung problems
- Liver problems
- Epilepsy or recurrent seizures
- Panic attacks
- A family history of schizophrenia
- A history of psychosis or mood disorders
- A history of serious mental health disorders including schizophrenia or psychosis, unless specifically prescribed by a qualified healthcare professional with a knowledge of your psychiatric history.
- A history of substance use disorder (abuse, dependence) to alcohol, opioids, stimulants, benzodiazepines, or any prescription or non-prescription substances.

Pregnancy and breastfeeding

Check with your doctor if you are pregnant or intend to become pregnant. Talk to your doctor if you are breastfeeding or intend to breastfeed.

Cultiva Frosted Oranges AIO Live Resin Vaporiser is not safe to take if you are pregnant or intend to become pregnant or if you are breastfeeding or intend to breastfeed. Talk to your doctor before commencing Cultiva Frosted Oranges AIO Live Resin Vaporiser.

Use in children

Cultiva Frosted Oranges AIO Live Resin Vaporiser is not recommended for use in children or adolescents younger than 18 years.

03. What if I am taking other medicines?

Tell your doctor or pharmacist if you are taking any other medicines, including any medicines, vitamins or supplements that you buy without a prescription from your pharmacy, supermarket or health food shop. You should also tell any healthcare practitioner who is prescribing a new medication for you that you are taking Cultiva Sticky Papaya Live Resin Inhalation Cartridge, always let your healthcare practitioners know all the medications you are taking. Some medicines may interfere with Cultiva Frosted Oranges AIO Live Resin Vaporiser and affect how it works. Cultiva Frosted Oranges AIO Live Resin Vaporiser may also affect how other medicines work.

Tell your doctor if you are taking medicines for:

- Sleeping problems (sleeping pills, sedatives, hypnotics e.g., pentobarbital, zopiclone, zolpidem, benzodiazepine, diphenhydramine, promethazine)
- Attention Deficit Hyperactivity Disorder (ADHD) or narcolepsy (e.g., methylphenidate, pemoline)
- Epilepsy, seizures, nerve pain (e.g., carbamazepine, phenytoin, phenobarbital)
- Pain (e.g., opioids such as codeine, morphine, oxycodone)
- Blood clotting (coumarins, e.g., warfarin)
- Cold, allergy or congestion (e.g., oxymetazoline, propylhexedrine, pseudoephedrine, antihistamine)
- Fungal infection (e.g., ketoconazole, itraconazole, fluconazole)
- Bacterial infection (e.g., erythromycin, rifampicin, clarithromycin)
- Muscular conditions like muscle spasms, overactive bladder, movement disorders (Parkinson's disease), asthma (anticholinergics: e.g., tiotropium, darifenacin, solifenacin, benzotropine mesylate, trihexyphenidyl, ipratropium, bromides)
- Immune conditions like rheumatoid arthritis, nephrotic syndrome, Crohn's disease, organ transplant rejection, psoriasis (cyclosporine); HIV/AIDS (ritonavir)
- Irregular heartbeat (amiodarone)
- Major depressive disorder, obsessive-compulsive disorder, premenstrual dysphoric disorder, bulimia nervosa, panic disorder (fluoxetine)

Check with your doctor or pharmacist if you are not sure about what medicines, vitamins or supplements you are taking and if these affect Cultiva Frosted Oranges AIO Live Resin Vaporiser.

04. How do I use Cultiva Frosted Oranges AIO Live Resin Vaporiser?

How much to take

- Follow the directions of your doctor or pharmacist carefully.
- Your doctor will provide you with a treatment schedule based on your medical condition and needs.
- A titration period (gradually increasing the dose) is required to reach the best dose.

Cultiva Frosted Oranges AIO Live Resin Vaporiser dosage

- The dose and frequency of use required will vary between patients.
- Your doctor may recommend you increase the dose slowly to reach the lowest dose needed to improve your symptoms.
- Always use Cultiva Frosted Oranges AIO Live Resin Vaporiser exactly as your doctor has prescribed. Check with your healthcare provider or pharmacist if you are not sure.
- Effects from Cultiva Sticky Papaya Live Resin Inhalation Cartridge has a rapid onset and may begin within approximately 5-30 minutes and may last for approximately 4-8 hours, depending on dosage, how long you have been taking the medication and your individual response
- Do not exceed recommended dosage

Follow these instructions to take the medication

- Open the packaging and remove the All-in-one Inhalation Cartridge
- Cartridge is draw activated and ready to use, it does not require any additional batteries or devices
- Inhale for 1-3 seconds then exhale
- Wait 15 minutes to determine if effects are aiding with your symptoms
- When to take Cultiva Frosted Oranges AIO Live Resin Vaporiser
 - Cultiva Frosted Oranges AIO Live Resin Vaporiser can be taken before or after food.
 - Taking Cultiva Frosted Oranges AIO Live Resin Vaporiser under similar conditions each day may help achieve a more consistent effect.
- How to take Cultiva Frosted Oranges AIO Live Resin Vaporiser
 - Cultiva Frosted Oranges AIO Live Resin Vaporiser should be taken as directed by your doctor.
 - Cultiva Frosted Oranges AIO Live Resin Vaporiser is available as dried medicinal cannabis flower and is designed for inhalation using a TGA-approved vapouriser.

If you forget to take Cultiva Frosted Oranges AIO Live Resin Vaporiser

- Cultiva Cultiva Frosted Oranges AIO Live Resin Vaporiser should be taken regularly at the same time each day.
- If you have trouble remembering when to use your medicine, talk to your pharmacist or doctor.
- If it is almost time for your next dose, skip the dose you missed and take your next dose when you are meant to.
- Speak to your doctor or pharmacist to understand when it is too close to your next dose.

- Do not take a double dose to make up for the dose you missed.
- If it is almost time for your next dose, skip the dose you missed and take your next dose when you are meant to.
- Speak to your doctor or pharmacist to understand when it is too close to your next dose.
- Do not take a double dose to make up for the dose you missed.

If you use too much Cultiva Frosted Oranges AIO Live Resin Vaporiser

If you think you have used too much Cultiva Frosted Oranges AIO Live Resin Vaporiser, you may need urgent medical attention. You should immediately:

- Phone the Poisons Information Centre (by calling 13 11 26) or,
- Contact your doctor, or go to the Emergency Department at your nearest hospital

You should do this even if there are no signs of discomfort or poisoning.

05. What should I know while using Cultiva Frosted Oranges AIO Live Resin Vaporiser?

Things you should do

- Take Cultiva Frosted Oranges AIO Live Resin Vaporiser as your doctor has prescribed.
- Always use Cultiva Frosted Oranges AIO Live Resin Vaporiser under medical supervision to help determine if the product is working or if you are having any side effects from the treatment.
- Talk to your doctor or pharmacist if you do not feel better, or if you feel worse.
- If you are starting any new medicine, remind your doctor and pharmacist that you are taking Cultiva Frosted Oranges AIO Live Resin Vaporiser.
- Remind any doctor, pharmacist, dentist or other healthcare provider who is treating you that you are taking Cultiva Frosted Oranges AIO Live Resin Vaporiser.
- Tell your doctor if you become pregnant while taking Cultiva Frosted Oranges AIO Live Resin Vaporiser.
- Tell your doctor if your symptoms do not improve.

Call your doctor straight away if you:

- Are pregnant or become pregnant while taking Cultiva Frosted Oranges AIO Live Resin Vaporiser.
- Need to have any medical tests as Cultiva Frosted Oranges AIO Live Resin Vaporiser may affect the results of some tests.

Things you should not do

- Do not give your medicine to anyone else, even if they have the same condition as you.
- Do not change your dose without talking to your doctor about it first.
- Do not stop taking your medicine without telling your doctor.
- If you stop taking your medicine suddenly or change the dose, your condition may worsen, or you may have unwanted side effects.
- Do not consume alcohol while you are taking Cultiva Frosted Oranges AIO Live Resin Vaporiser. Alcohol in combination with Cultiva Frosted Oranges AIO Live Resin Vaporiser can impair cognitive abilities, including coordination, reaction time and motor skills.
- Do not drive or operate complex machinery for 24 hours after taking Cultiva Frosted Oranges AIO Live Resin Vaporiser.
- Do not use Cultiva Frosted Oranges AIO Live Resin Vaporiser to treat any other complaints or symptoms unless directed by your doctor

Travelling with Cultiva Frosted Oranges AIO Live Resin Vaporiser

- Cultiva Frosted Oranges AIO Live Resin Vaporiser is a controlled drug, and its legal status will vary between countries.
- Check if it is legal for you to take this medicine into any countries you are travelling to or through, including countries you are transiting through, and your final destinations.
- Consult with your doctor, country consulates, The Department of Foreign Affairs and Trade, insurance company and/or pharmacist to confirm if it is legal for you to travel with Cultiva Frosted Oranges AIO Live Resin Vaporiser.

Driving or using machines

- Do not drive or operate heavy or dangerous machinery while being treated with Cultiva Frosted Oranges AIO Live Resin Vaporiser.
- Talk to your doctor about when you can resume these activities after completing treatment.

Drinking alcohol

- Tell your doctor if you drink alcohol.
- Alcohol may increase the effects of Cultiva Frosted Oranges AIO Live Resin Vaporiser, or the latter may increase the effects of alcohol (such as loss of balance or ability to respond quickly).

Looking after your medicine

- Store below 25°C.
- Your medication should be stored in its originally labelled packaging
- Follow the instructions in the carton on how to take care of your medicine properly.
- Store Cultiva Frosted Oranges AIO Live Resin Vaporiser in a cool dry place away from moisture, heat or sunlight; for example, do not store it:
 - In the bathroom or near a sink, or
 - In a car, or on windowsills.
- Keep it where young children cannot reach it.

Getting rid of any unwanted medicine

- If you no longer need to use this medicine or it is out of date, take it to any pharmacy for safe disposal.
- Keep out of reach of children.
- Do not use this medicine after the expiry date.

06. Are there any side effects?

All medicines can have side effects. If you do experience any side effects, most of them are minor and temporary and generally as a result of first taking the medication. Please refer to the section on "How much to take". However, some side effects may need medical attention.

See the information below, and, if you need to, ask your doctor or pharmacist if you have any further questions about side effects.

Mild side effects

Mental status:

- Memory impairment
- Difficulty concentrating
- Dizziness
- Light-headed feeling
- Fatigue
- Daytime drowsiness

Eyes:

- Dry eyes
- Bloodshot eyes
- Altered visual perception

General:

- Headache
- Increased appetite
- Nausea
- Phlegm and cough
- Dry mouth
- Muscle weakness
- Malaise (feeling generally unwell) or a general feeling of discomfort

Ears:

- Altered hearing perception

What to do

Speak to your doctor if you have any of these less serious side effects and they worry you.

Serious side effects

Mental status:

- Depression
- Thoughts of suicide
- Abnormal thoughts
- Paranoia
- Euphoria
- Seeing or hearing things that are not there
- Irrational thinking
- Hallucinations
- Psychosis
- Addiction / dependence
- Agitation
- Confusion
- Disorientation

Brain / Nervous system:

- Numbness
- Burning sensation

What to do

Call your doctor, or go straight to the Emergency Department at your nearest hospital if you notice any of these serious side effects.

Tell your doctor or pharmacist if you notice anything else that may be making you feel unwell. Other side effects not listed here may occur in some people.

Reporting Side Effects

After you have received medical advice for any side effects you experience, you can report side effects to the Therapeutic Goods Administration online at www.tga.gov.au/reporting-problems. By reporting side effects, you can help provide more information on the safety of this medicine.

Always make sure you speak to your doctor or pharmacist before you decide to stop taking any of your medicines.

This medicine's name is Cultiva Sticky Papaya AIO Live Resin Vaporiser, and it is provided as an All-in-one 1g vaporiser device, cannabis extract has the appearance of a light to dark yellow-gold liquid.

delta-9-tetrahydrocannabinol (800mg/1g THC)
